<sup>1</sup> The above chemistry is supplied as an approximate guide to the composition of this setup sample and must not be regarded as a certified analysis. The analysis is based on the results of the homogeneity testing performed on the sample lot. This sample was found to be suitable for use as a setting-up sample and may be used for instrument drift control. It must not be used for instrument calibration.

The requirements of ISO Guides 31, 34, and 35 were followed for the preparation of this setting-up sample and data sheet.

**Homogeneity:** This setting-up sample (SUS) was tested for homogeneity using ASTM Standard Method E 826 and found acceptable. It was also examined by spark atomic emission spectrometry and found to be compatible with the following Reference Materials — 501-676, 502-257; BS HON-T, 68E, 4150M; CMSI 2072, 2074, 2075; ECRM 195-1D, 532-1; NCS HC37037, NS11019; SRM 364.

**Validity statement:** ISO Guide 31 states that the data sheet should contain an expiration date for all samples where instability has been demonstrated or is considered possible, after which the stated values are no longer guaranteed by the producing body. The stated values for BS SU 4942 are valid indefinitely. However, they are nullified if this SUS is damaged, contaminated, or otherwise modified.

**Source:** The bar stock for this SUS was supplied by Next Generation Metals; Boca Raton, FL.

**Form:** This SUS is machined in the form of a disc, approximately 38 mm in diameter and 40 mm thick by Brammer Standard Company, Inc.

**Use:** This SUS is intended for use in spark atomic emission and x-ray spectrometric methods of analysis. Refer to ISO Guide 33 for information about the use of setting-up samples. It is intended as a setup standard to be used for controlling instrument drift.

**Analytical Area:** The entire depth of the SUS may be used.

Caution: As with any bar sample, avoid spark atomic emission spectrometric burns in the center of the SUS (5 mm radius), as some segregation may be present.

**Sample Preparation:** For best analytical results, use the same method for preparing the analytical surface on all setting-up samples as you use for production specimens. Avoid overheating the sample during surface preparation.
